## No. 01: Royal Decree: Race Theory in Canada 2.0

Her Majesty I AM Queen Romana @romanadidulo Head of State & Commander-in-Chief, Head of Government, Queen, and President, [6/23/2021 8:11 AM, PT]

Re: Race Theory in Canada 2.0

Effective today, "Race Theory" in Canada is unlawful. All private and public are:

- 1) Daycare Centers
- 2) Pre-schooler facilities
- 3) K-12
- 4) Trade Schools/ Colleges/Universities
- 5) Military Schools and Military Barracks & Libraries.

All Textbooks/digital & hard copies, copies/other teaching methodologies regarding "Race Theory" are to be removed and destroyed effectively immediately.

Promotion, dissemination, and selling of, "Race Theory Materials" in any form in Canada and to Canadians is unlawful.

The Penalty for violating this Royal Decree includes the revocation of business licenses, immediate closure of said business/facilities, and a minimum of 30 years imprisonment without bail or parole.

#### No. 02: Royal Decree: Sex Education – school curriculum (private/public)

Effective today, students taking "sex education classes" must meet the minimum age requirement of 24 years old age or older.

The Penalty for violating this Royal Decree minimum of 30 years of imprisonment without bail or parole (first offense), and lifetime imprisonment (second offense).

#### No. 03: Royal Decree: Age of Consent (sexual relations)

Re: Age of Consent (sexual relations)

Effective today, the #lawful age of #consent to sexual relations is 24 years old or older.

The Penalty for violating this Royal Decree is a minimum of 30 years of imprisonment without bail or parole (first offense), and lifetime imprisonment (second offense).

## No. 04: Royal Decree: Age of Consent - Marriage in Canada

Her Majesty I AM Queen Romana @romanadidulo Head of State & Commander-in-Chief, Head of Government, Queen and President, [6/23/2021 9:03 AM, PT]

Re: Age of Consent - Marriage in Canada

Effective today, the lawful age of consent to marry is 24 years old or older in Canada. And, must meet the following requirements:

- 1) Age 24 and older
- 2) Attend one month of Pre-Marital Seminars (married life, children, responsibilities of raisingchildren, financial responsibilities, etc.)
- 3) Both individuals applying for a marriage license must be Canadian/permanent Residence of Canada.

The Penalty for violating this Royal Decree is a minimum of 30 years imprisonment without bail or parole including the expulsion from Canada of the violating party who is not a Canadian or not a permanent Resident.

#### No. 05: Royal Decree: Airlines (Domestic + International)

Re: Airlines (Domestic + International)

Airlines companies requiring passengers to first be injected with pharmaceutical industry-concocted poison disguised as vaccines or PCR tested, effective today, are not permitted to land in Canada 2.0 or do Business inside Canada 2.0.

These Airlines' operating business licenses and landing permits in Canada are hereby revoked with immediate effect.

Penalties for violating this Royal Decree are Five\_Billion\_Canadian\_Dollars (\$5,000,000,000.00) DAILY and will be charged for Crimes Against Humanity.

### No. 06: Royal Decree: Cruise Ships (Domestic + International)

Her Majesty I AM Queen Romana @romanadidulo Head of State & Commander-in-Chief, Head of Government, Queen and President, [6/25/2021 11:49 AM, PT]

Re: Cruise Ships (Domestic + International)

Cruise Ships companies requiring passengers to first be injected with pharmaceutical industry-concocted poison disguised as vaccines or PCR tested, effective today, are not permitted to dock in Canada 2.0 or do Business inside Canada 2.0.

These Cruise Ships operating business licenses and docking permits in Canada are hereby revoked with immediate effect.

Penalties for violating this Royal Decree are Five\_Billion\_Canadian\_Dollars (\$5,000,000,000.00) DAILY and will be charged for Crimes Against Humanity.

#### No. 07: Royal Decree: Unlawful Residential and Commercial Foreclosures in Canada

Re: Unlawful Residential and Commercial Foreclosures in Canada

Banks/Financial Institutions/Cooperative Memberships Banks, and money lender companies (Domestic + International) are hereby ordered to immediately Cease and Desist (C&D) ALL Residential and Commercial Property Foreclosures in Canada.

Penalties for violating this Royal Decree are Five\_Billion\_Canadian\_Dollars (\$5,000,000,000.00) DAILY and shall have their license #revoked, and assets seized.

### No. 08: Royal Decree: Corporations, Foundations, NGOs, Cooperatives, etc in Canada

Her Majesty I AM Queen Romana @romanadidulo Head of State & Commander-in-Chief, Head of Government, Queen and President, [7/7/2021 12:57 PM, PT] Retroactive – May 28, 2021.

It is unlawful for Corporations, Foundations, NGOs, Cooperatives, etc in Canada to require their staff (paid or volunteer) to have coronavirus injections/wear masks/take PCR tests, to continue employment.

An Employee's/Volunteer's refusal to inject poison (experimental drug) into his or her body is NOT a lawful cause to terminate employment.

This includes causing an employee/volunteer to inject, under DURESS, herself/himself the experimental drug (coronavirus injection).

Violation of this Royal Decree will result in the following:

#### No. 10: Royal Decree: Canada Border Services Agency (CBSA)

## No. 12: Royal Decree: Canadian Food Inspection Agency (CFIA)

Re: (Federal/Provincial/Territorial) Canadian Food Inspection Agency (CFIA)

CFIA Canada is prohibited from issuing public health guidelines/recommendations Nationwide.

Furthermore, the collaboration between US Food and Drug Administration (FDA), Health Canada, and CFIA are hereby revoked.

This order is retroactive to May 28, 2021.

#### No. 13: Royal Decree: Canadian Military Generals/Officers

I, Queen Romana of Canada, hereby issue this Royal Decree reinstating in full their previous post(s) and ranks ALL Canadian Military Generals and Officers falsely accused of sexual misconduct / politically persecuted.

This Royal Decree is retroactive to the date and time the Generals/Officers were unlawfully dismissed from their positions and ranks.

Furthermore, all promotions which directly resulted from such unlawful dismissal of these persecuted Generals/Officers are hereby rescinded.

## No 14: Royal Decree: School Closures

Note: Home Schools are exempt from this Royal Decree prohibitions under the following conditions:

- b) Do PCR tests or
- c) Be vaccinated.

The penalty for failing to adhere to this Royal Decree is death; trial via Military Tribunal.

## No. 16: Royal Decree: Lawful – I owe You Note(s)

Her Majesty I AM Queen Romana @romanadidulo Head of State & Commander-in-Chief, Head of Government, Queen and President, [9/03/2021 7:48 AM, PT]

I, Queen Romana Didulo of Canada hereby Decree lawful the use of "I Owe You Note(s)" in Canada.

I Owe You Notes can be used for the following:

- 1) Housing (Rent/Mortgage)
- 2) Food & Water for men, women, children, and Animals
- 3) Home -Electricity
- 4) Home -Hydro
- 5) Basic Home Cable
- 6) Basic Home Phone
- 7) Basic Cell Phone
- 8) Basic Home Internet
- 9) Gas for heating Homes & for operating vehicles
- Medicine not covered by Pharmacare 11) Basic Dental Care, Extraction, and maintenanceof Dentures
- 12) Public Transportation.

\*Note – I Owe You Notes must be presented in person with ID and contact details.

If no ID is available another man/woman of the age of majority with ID may vouch for the Individual presenting the I Owe You Notes.

These "I owe you notes = Promissory Notes" will be payable by, "The Kingdom of Canada (a.k.a – Canada 2.0)".

This Royal Decree is effective August 31, 2021.

Violation of this Royal Decree is punishable by a minimum of 30 years imprisonment and or a financial penalty of no less than Ten (10) billion dollars payable in cash – money backed by gold (only).

### No. 17: Royal Decree: Removal of Children from Home Unlawful

Her Majesty I AM Queen Romana @romanadidulo Head of State & Commander-in-Chief, Head of Government, Queen and President, [9/03/2021 12:17 PM, PT]

I, Queen Romana of Canada hereby Decree unlawful the removal of Children from their Homes from the care of their biological parents or legal Guardians for whatsoever reason(s).

## No. 18: Royal Decree: Public Sidewalks/Boulevard/ Rural/Urban Areas/Residential-detached

Homes (front and back yard)/High-rise Residential buildings (Rooftop and Patios.), City/Community Gardens/Residential Gardens/Greenhouses/Schools

Her Majesty I AM Queen Romana @romanadidulo Head of State & Commander-in-Chief, Head of Government, Queen and President, [9/8/2021 9:57 AM, PT]

- I, Queen Romana Didulo of Canada, hereby Decree lawful the following:
- 1) The planting of Organic Fruit Trees, Vegetables, medicinal herbs, and Flowers along PublicSidewalks/Boulevards/ Rural/Urban Areas/Residential-detached Homes (front and back yard)/High-rise Residential buildings (Rooftop and Patios.),
- 2) All Cities in Canada must have community/city gardens sufficient to feed their Residents allyear round.
- 3) Where necessary, asphalt Streets/paved Streets may be removed and vehicular trafficrerouted to allow for more community gardens/ city gardens in highly populated areas.

- 4) All Residential buildings in Cities must have rooftop gardens and Patios for vertical/horizontalgardening.
- 5) Cities and town planners must incorporate City/Community Gardens in all their Planning. This Royal Decree is effective September 8, 2021.

# No.19: Royal Decree: Back Alleys/Residential Streets/Roads (Winter, Spring, and Summer Months) yearly events.

Her Majesty I AM Queen Romana @romanadidulo Head of State & Commander-in-Chief, Head of Government, Queen and President, [9/8/2021 11:15 AM, PT]

- I, Queen Romana of Canada hereby Decree lawful the following:
- 1) Each year beginning day one of the Spring Season to the last day of the Summer Season allback Alleys/Residential Streets/Roads must have, ONE to FIVE (1-5) /KPH Zone signs in all Cities and Towns.
- \*This is to allow all children to play safely outdoors in their Neighbourhoods during Winter, Spring, and Summer Months.
- \*\*Road Hockey, Snowball fights, Basketball, kids learning to Rollerblade, etc, are returning to your Neighbourhoods.
- 2) Emergency Vehicles/Patrolling Police Cars must have their sirens turned on before enteringand exiting the ONE to FIVE (1-5) /KPH Zones.

This Royal Decree is effective on day one of the Spring Season, the year 2022.
